

RESOLUTION NO. 24-55

RESOLUTION AMENDING RS-2015-24, PRESCRIBING ANCILLARY FEES AND CHARGES TO THE MADE BY THE CITY OF MONTICELLO'S WATER SYSTEM

WHEREAS, Municipal Code, §25-39, adopted as Ordinance 493, authorized the City to set fees and charges for installation, disconnection, street cuts, and other service charges associated with City's water system with approval from the City Council by resolution;

WHEREAS, the last approval of increasing of the schedule of fees and charges associated with City's water system was in 2015 by adopting Resolution RS-2015-24;

WHEREAS, the City's water department has increased ancillary fees and charges associated with operating the City's water system over the years to match an increase in cost for supplies and labor since 2015;

WHEREAS, City Council has found it important to approve the updated water system fees and charges to meet current expenses for supplies and labor.

NOW, THEREFORE BE IT RESOLVED by the City Council of Monticello, Arkansas that Resolution RS-2015-24, A Resolution Amending Resolution 92-11, Prescribing Ancillary Fees and Charges to be Made by the City of Monticello's Water System, is hereby repealed and the following adopted to be effective immediately:

1. The following fees ("tap fees"), due and payable in advance, shall be charged by the City for the listed service:

2. The charge for making a bore to install any utility beneath any street maintained by the city shall not be less than \$500 and shall be fixed by the Mayor, and beneath any other street or highway shall be fixed by the Mayor.

3. The charge for each water system service call or special service ("service charges") for special readings for meters, disconnects, and re-connects, setting up certain water accounts, etc., shall be \$10.00 per visit inside the City, \$15.00 per visit outside the City, and \$25.00 per visit outside regular, published business hours.


4. In any case where the City disconnects a water service line because of non-payment of water service charges, a service charge of \$25.00 will be made for re-connecting said line.

5. In the even a water service charge is attempted to be paid with a worthless or "hot" check (i.e., a check for the payment of money upon a bank where the maker of such check has insufficient funds on deposit with such bank for the payment of the check), a charge of \$25.00 will be made by the City on account of such attempted payment; and if such \$25.00 charge is not paid within seven (7) business days after notice of the worthless check is given by the City to the customer, water service to the subject location will be discontinued.
