**RESOLUTION ADOPTING SOLID WASTE POLICY**


WHEREAS, the Monticello City Council has reviewed and approved policy 25-1110 which clearly states the policy on City Solid Waste services


WHEREAS, City Polity 25-1110 is attached to and considered part of the resolution and identified as "Exhibit 1";

**POLICY NUMBER 25-1110**  
**WATER AND SOLID WASTE SERVICE - RESIDENCY/SERVICE REQUIREMENT**

**PURPOSE:** To alleviate conflict and confusion relating to existing Ordinances applicable to the administration of the City Water and Sewer Services and to provide remedy for past, present and future circumstances that cause rise for conflict in matters relating to the delivery of said services.

The following policy is enacted:

**I. Accounts to Receive City of Monticello Solid Waste Services**

- a. Upon implementation of this policy, all **NEW** water service accounts opened for locations inside the city limits of Monticello will utilize the existing City of Monticello Solid Waste (trash) service. Pursuant to Ordinance 533 Section 2, this service is to be billed at the standard monthly rate as set by ordinance whether it is utilized or not by the water customer. Notification of this requirement is to be provided to the customer at the time of the account activation.
- b. The Mayor may at his or her discretion and based on extenuating circumstances present at the time, allow a secondary or other solid waste arrangement if it is determined to be in the best interest of the City of Monticello to permit the city and / or account holder to do so.
- c. Any such finding as allowed in section B of this policy is to be notated in the customers account profile.

**II. County Residents Receiving City Water Services**

- a. County residents who receive city water services are not required to utilize city solid waste services. County Ordinances regulate the solid waste requirements of County residents, with City Ordinances regulating City of Monticello residents.
- b. Due to past inconsistencies in the enforcement of matters relating to Ordinances 522, 533(2) and subsequent similar ordinances, any delinquent fees, charges or past due amounts owed to the City of Monticello relating to matters pertained to in this policy that are owed prior to the date of the adoption of this policy may be considered void with written approval of the Mayor.
